### Rules & Information

1. Entry forms and rider release deadline will be **February 15, 2019 at 5 P.M.** Application must be returned to the Orange Convention and Visitors Bureau office, located at 803 W. Green Avenue, or by email at [hgravett@orangetexasgov.us](mailto:hgravett@orangetexasgov.us)
2. Proper Vehicle insurance in accordance with state law is required and must be submitted with a copy of driver's license with the completed entry form.
3. Registration fee - FREE
4. Vehicles must be decorated with Mardi Gras décor/theme.
5. Sufficient traditional Mardi Gras throws required per rider for a three-mile parade; no candy permitted.
6. Drivers must observe all normal traffic rules when entering staging area and when disbanding at the end of the parade.
7. **NO horses, NO dogs, NO Pets.**
8. Children are to be escorted and supervised by a parent, guardian, or chairperson during the **ENTIRE** length of the parade. Drivers must be 18 years of age or older.
9. No political advertisements for persons seeking election to an office.
10. There will be limited parking for participants, please make accommodations to carpool to the event.
11. Staging will begin at 5 P.M. along 7<sup>th</sup> Street between Division Avenue and Front Avenue.
